





# **Research Highlights FY23**

Research is one of the core activities of Transforming Chaplaincy. In FY23 Transforming Chaplaincy, and colleagues affiliated with us, have been involved in 30 research projects. A complete list of those projects appears on the following pages. Below we have highlighted four of them. These research activities have led to 15 peer-reviewed publications and one book chapter. The peer-reviewed publications address spiritual care for healthcare workers, spiritual care in the Covid-19 pandemic, spiritual care leadership in a time of racial reckoning, spiritual care services in the leading hospitals in the US, and the role of religion and spirituality in serious illness and population health among other topics. A complete list of these publications can be found in the Appendices.

### Transforming Chaplaincy Collaborates on 2 NIH Proposals

A major highlight for the Transforming Chaplaincy research program in FY23 was collaboration on two major proposals to the NIH. The first proposal was "Leveraging Spirituality to Control Diabetes: A Faith Based Multi-Component Intervention for African Americans with T2DM (FAITH - DM)." This project is led by Dr. Leonard Egede and colleagues at the Medical College of Wisconsin. The aim of the project is to test the benefits of adding spiritual care to a diabetes education program for African-American patients with poorly controlled diabetes. George Fitchett, Senior Advisor for TC, and Charles Valenti-Hein, Chaplain Specialist, On Demand Spiritual Care Ascension are Co-Investigators. In June 2023, the project received positive reviews. The team is revising the proposal for resubmission. The second project was the "Chaplain Family Project Multicenter RCT." This project is led by Dr. Alexia Torke and colleagues, including chaplain-research Shelley Varner-Perez, at IU Health. The aim of this project is to test the benefits of the SCAI intervention in a large and diverse sample of ICU family surrogates. George Fitchett is a Co-Principal Investigator and Csaba Szilagyi, Director of TC, is a Co-Investigator for this project. The project was submitted to the NIH in June 2023.

#### Addressing Moral Injury in Health Care Workers

In FY23, Tim Usset, Convener of Transforming Chaplaincy's PTSD, Moral Injury, & Spiritual Distress Network, was active in research that addressed issues of stress and resilience in healthcare workers, and specifically the issue of moral injury (MI). This work included an extensive scoping review of research about MI in healthcare workers (Griffin et al., 2023). Building on their review, the team generated a model for MI in healthcare workers that describes individual, organization, and

system-level factors associated with MI. In another publication Tim and colleagues reported a meta-analysis of RCTs designed to address MI; the studies focused primarily on service members and veterans (Aita et al., 2023). The review, which included two RCTs of the Building Spiritual Strengths (BSS) intervention, found that evidence-based treatments for MI are comparable to conventional trauma treatments for attenuating PTSD symptoms and are superior in attenuating MI symptoms. In a third paper, Tim and colleagues (Chamberlin & Usset, et al., 2023), report on the development of Health and Strength (HAS); a spiritually integrated intervention designed to address moral distress and injury in healthcare workers. Based on the BSS intervention, HAS is a 6-session, group intervention that is co-led by a chaplain and mental health professional. The aim of HAS is to help healthcare workers connect with their values, faith, and spirituality; increase their appreciation for moral complexity and dilemmas; and increase their capacity for self/other forgiveness. An RCT of HAS is currently underway.

### Spiritual Care Mapping Research Extended

In FY23 we extended our mapping of spiritual care services to new contexts. In FY22 we studied spiritual care services and staffing in the 20 Honor Roll hospitals (Tartaglia et al., 2023). This year we launched a project to conduct a similar study in 100 community hospitals; a sample that will allow greater generalizability of the findings. We also began work on studies of spiritual care services in leading pediatric hospitals and in outpatient cancer centers. Finally, we studied the involvement of spiritual care programs in community wellness initiatives. All of these projects were supported by grants from Rush's College of Health Sciences and conducted in collaboration with Kelsey White and her colleagues at Virginia Commonwealth University.

### Muslim Chaplains in the Clinical Borderlands

This year Lance Laird and Samsiah Abdul-Majid published their report about Muslim healthcare chaplains. Their study is based on interviews with a diverse sample of 20 Muslim chaplains. In the report they describe how these chaplains "interpret their authority, function, and identity within a professional space defined by dominant American religious norms as well as by shifting standards for leadership within American Muslim communities." The project was supported by an Association of Professional Chaplains and Transforming Chaplaincy Pilot Project Grant.



# **Spiritual Care Management and Leadership Certificate**

Twenty-four chaplain leaders participated in the 2023 Spiritual Care Management and Leadership Certificate program. It prepares current and future spiritual care managers to lead dynamic and effective spiritual care programs in a rapidly changing healthcare environment. Participants met virtually between January and September and attended the in-person Capstone Seminar at Rush University in Chicago (September 20-22). # **Research Literacy Online Courses**

### Research Literacy (RL) for Clinical Pastoral Education (CPE)

We developed a new online research literacy course designed for CPE students, which helps educators incorporate research literacy into their CPE residency programs. In FY23, 28 CPE students from six residency groups completed the RL for CPE course. The RL for CPE course instructors included Allison DeLaney, Dirk Labuschagne, and Csaba Szilagyi.

This introductory course aims to help participants articulate the value of research and evidence-based practice and develop basic skills to identify, evaluate, and apply relevant research for evidence-based spiritual care. Students also undertake "Evidence-Based Spiritual Care" applied learning projects to apply their learning to address a clinical question pertinent to their spiritual care practice. Flexible course design allows students to complete it in a 3- to 6-month timeframe, customized by their CPE educator to integrate with the overall CPE curriculum. One participant wrote about their learning experience, "It was so user friendly and packed with so much helpful information. It dispelled any myths that research is inaccessible to chaplains."

Advancing a research-informed approach to spiritual care depends on chaplains developing research literacy. To support chaplain research literacy, we continued to offer our online research literacy courses: RL101, a five-week Introduction to Research Literacy, and RL 102, a 10-week Deeper Exploration for Chaplains. In FY23, 56 chaplains, including chaplains from Transforming Chaplaincy's partners, participated in RL 101, and 9 chaplains enrolled in RL 102. Course instructors included Beba Tata-Mbeng, Kim Palmer, and Allison DeLaney for RL1-2 and Paul Galchutt for RL101.

The main goal of these courses is to build research literacy skills: reading and applying research articles to the vital work chaplains do as front-line healthcare providers in religion and spirituality. The aims of these courses include enabling participants to articulate the rationale for chaplaincy as an evidence-based profession; identifying and accessing research literature related to spirituality, religion, and health; critically reading and evaluating current research pertaining to chaplaincy practice; and identifying ways of applying research to current practice. The RL102 course presents advanced content to help participants better understand research designs, methodologies, and applications. A participant commented about their experiences in the RL101 course: "Well done and well led course. Appreciated very much the online organization, check-boxes to keep from getting lost, flow of content, especially for those with little exposure/experience with research."

### Webinars, Webinar Journal Club, and YouTube

### **Webinars**

In FY23, Transforming Chaplaincy hosted 16 webinars. We had 2,844 people attend the webinars live (a site registered as attending might have several people listening), in addition to 5,440 YouTube views of webinar recordings. The webinars addressed diverse topics, including spirituality in serious illness, screening for spiritual needs, chaplaincy during the pandemic, perceived racial bias and potential impacts on spiritual care, patient-centered care and medical decision-making, the intersection of hospital finances and mission/spiritual care, strategic priorities for professional chaplaincy, relevance of religion and spirituality to mental health, religious and spiritual struggles among transgender and gender-nonconforming adults, chaplain case study research, and chaplain services in an outpatient primary care setting. A complete list of our FY22 webinars can be found in the Appendices.

### **Webinar Journal Club**

The series of five Webinar Journal Club sessions, hosted by the Association of Professional Chaplains (APC), is designed to help chaplains with no prior experience learn to read and understand research. It also introduces research-literate chaplains to important research that will inform their chaplaincy practice and their ability to advocate for its benefits. The theme for the calendar year 2022 was "Becoming More Evidence-Based in Your Chaplaincy Practice." The 2023 theme was "Research Across the Chaplaincy Landscape."

### YouTube

All the Transforming Chaplaincy webinars are available on our YouTube channel. In FY23, our 10 most viewed webinars had a total of over 6,447 views. The most viewed webinar was "What Can We Do When Prognosis Is Poor, the Patient Family's Hope Is for a Miracle and the Treatment Teams Feels Stuck," from August 2022. It had over 1,000 views in FY23. The 10<sup>th</sup> most viewed webinar was "Chaplain Documentation: A Review of Charting Spiritual Care: The Emerging Role of Chaplaincy Records in Global Health Care," from January 2021, which had nearly 400 views in FY23.
